From 1 July 2025, the ACT Government's Sustainable Household Scheme is no longer available for solar panel installations.

When does the solar battery rebate apply?

Start: The rebate applies to solar battery systems installed from 1 July 2025. Solar battery systems installed before 1 July 2025 will only be eligible if not activated until after the program begins. Max Rebate:: Up to 30% off the cost of an eligible solar battery system.

Will Australians benefit from the new solar battery rebate?

Australians may also benefit from the new Federal Solar Battery Rebate, officially launching on 1 July 2025 under the Cheaper Home Batteries Program. This confirmed national rebate will offer up to 30% off eligible battery



systems—potentially saving homeowners around \$3,500 to \$4,700 on a typical 10–13.5 kWh setup.

Who is eligible for the Act solar rebate?

To be eligible for this ACT solar rebate you must hold either an Australian Pensioner Concession or Veterans' Affairs Gold Card holders, have an eligible property which you own and occupy where the product will be installed, as well as attending a free Home Energy Support workshop.
