Are there solar rebates in Arizona?

There are no statewide Arizona solar rebates, but it does have the AZ solar tax credit. Arizona's tax credit is equal to 25% of system costs up to \$1,000, and it reduces your state income tax liability. There may be local energy efficiency rebates and financial incentive programs available to you.

Does Arizona have a solar tax credit?

In addition to the federal solar tax credit, Arizona residents are eligible for a 25% state solar tax credit, property tax exemption and sales tax exemption on solar equipment. The Grand Canyon State offers a solar tax credit of 25% of your installation costs, up to a maximum of \$1,000.

What incentives are available to promote solar energy adoption?



In addition to the plentiful sunshine, the state offers various financial incentives to promote solar energy adoption. These include a federal solar investment tax credit (ITC) that can offset some of the installation costs and state and local incentives like rebates, grants and property tax exemptions.

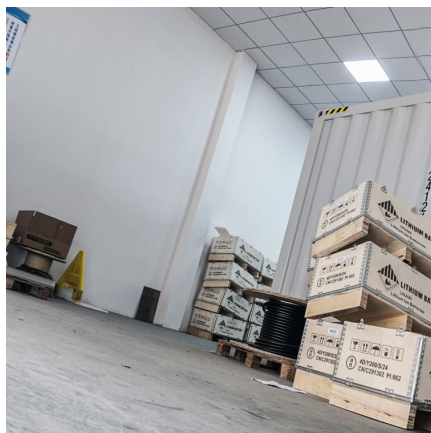
