Sexual battery laws in California are designed to protect individuals from unwanted and offensive touching, impacting both victims and those accused. What is sexual battery in California?

Sexual battery in California is defined under Penal Code Section 243.4 as the unlawful and intentional touching of an intimate part of another person for sexual arousal, gratification, or abuse. Consent is crucial, as the touching must be against the will of the person. The law covers both direct and indirect contact through clothing.

Can a person be convicted of sexual battery in California?

For you to be convicted of sexual battery under Penal Code 243.4 PC, prosecutors have the burden to prove beyond a reasonable doubt the following three elements of California Jury Instruction "CALCRIM" 938: For this crime to be a felony as opposed to a misdemeanor, the D.A. also has to prove one or more aggravating circumstance.

What are the penalties for sexual battery in California?

Penalties for sexual battery in California depend on whether it is a misdemeanor or felony, considering factors like the act's severity and the defendant's criminal history. Misdemeanor charges can result in up to six months in county jail and fines up to \$2,000, or \$3,000 if the victim was an employee and the perpetrator their employer.

Is sexual battery a felony?

Felony sexual battery (Penal Code 243.4 PC): Sexual battery is often charged as a felony if the circumstances are more serious—for example, physically restraining the victim or abusing a disabled person. A conviction for felony sexual battery can result in fines up to \$10,000 and up to 4 years in prison;.

What happens if you act as an accomplice to sexual battery?



When you act as an accomplice – also known as the crime of “ aiding and abetting ” – you face the same charges as the primary culprit. You were an “accomplice” to sexual battery if you: Penal Code 243.4 PC is California’s sexual battery law.

What are the defenses to sexual battery?

Understanding potential defenses is crucial for those accused of sexual battery. A common defense is consent, where the accused argues the victim consented to the contact. Evidence such as text messages or witness testimony can support this defense.

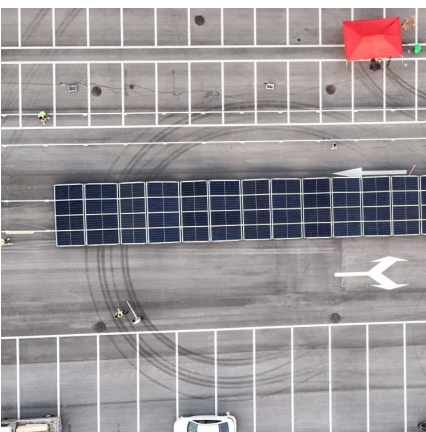

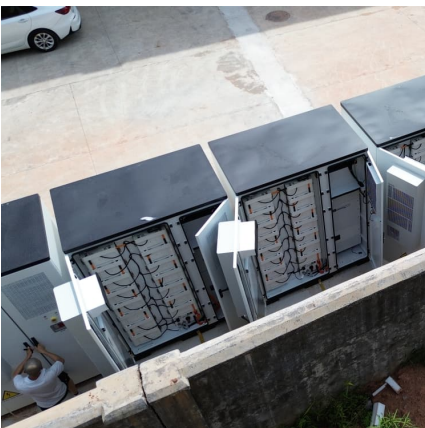
