compensation. According to research from Intuit QuickBooks, every \$1 spent on base salary costs an additional \$0.25-0.40 for the employer.

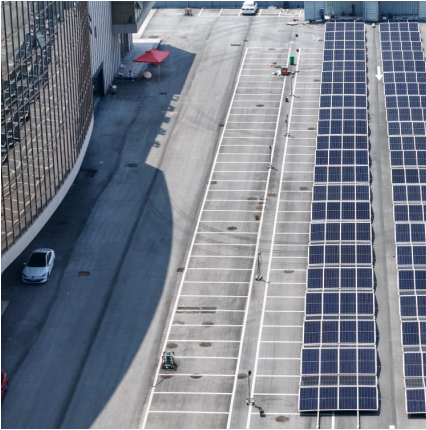
What benefits does a full-time employee get in Canada?

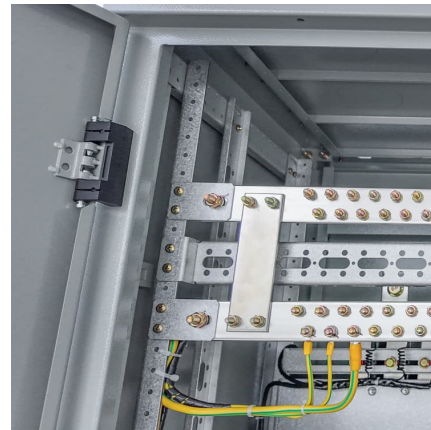
