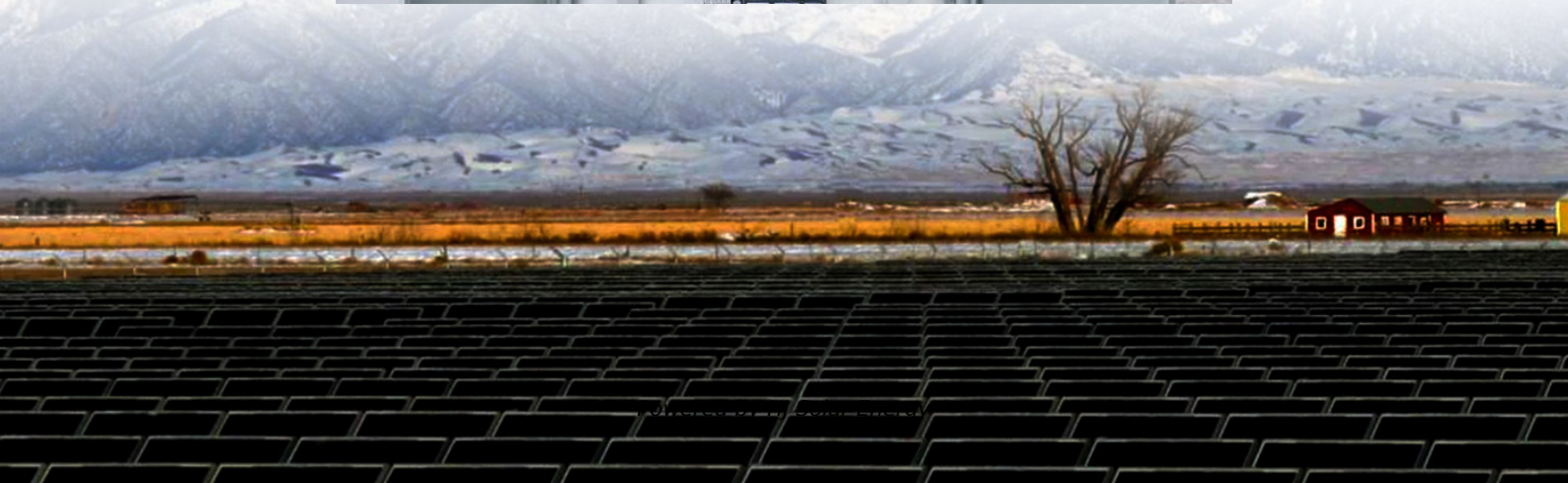

Why should New Zealand invest in grid-scale batteries?
