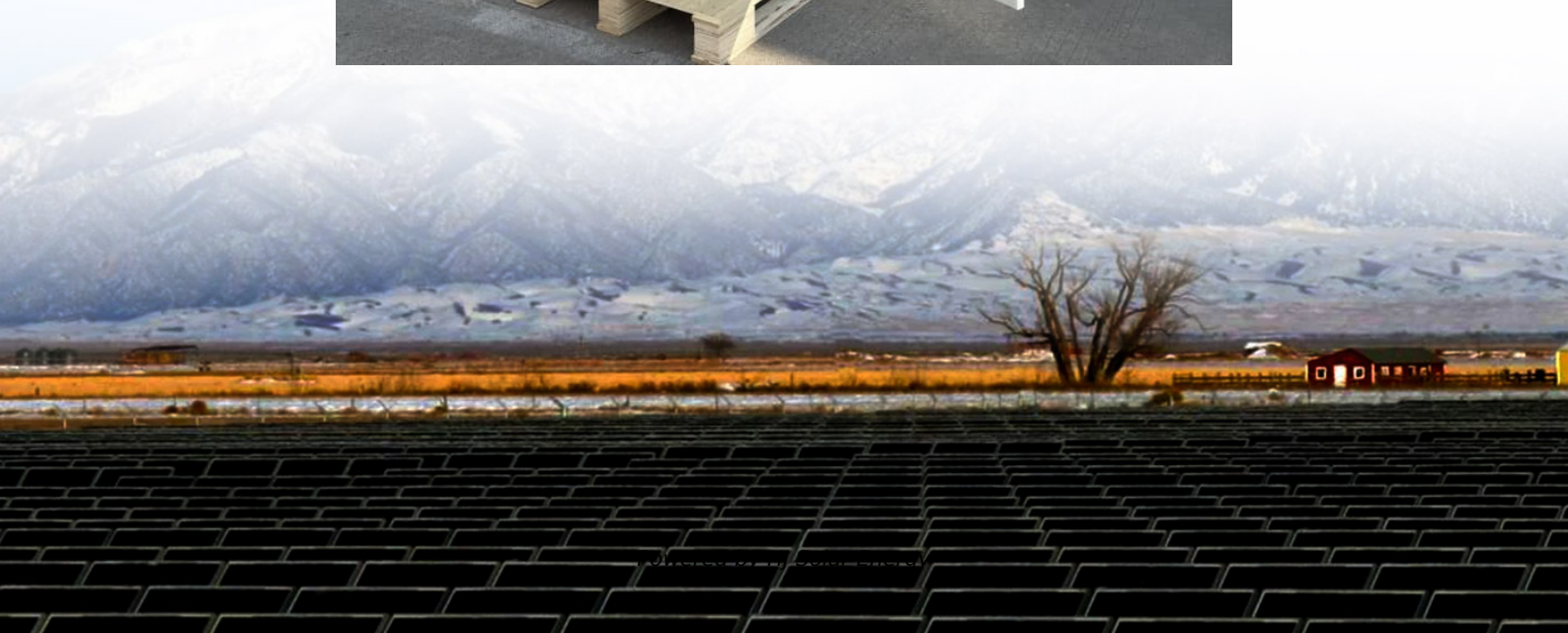

How much does a solar PV system cost in Ireland?

A solar PV system costs between €4,600 – €8,700 in Ireland in 2025 with the SEAI grant. The exact price will depend on the number and type of solar panels used. You can expect the peak solar output of your solar PV system to be between 1.76kWp to 7.04kWp.

Here's what you might pay to install Solar PV: depending on your type of home, the number of panels you opt for and the system size you choose (excluding grants). On the higher end of the range are families who seek greater energy independence.

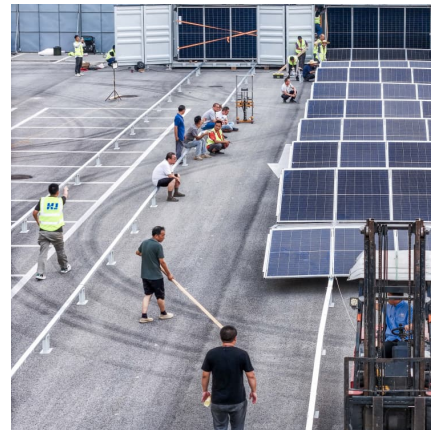
