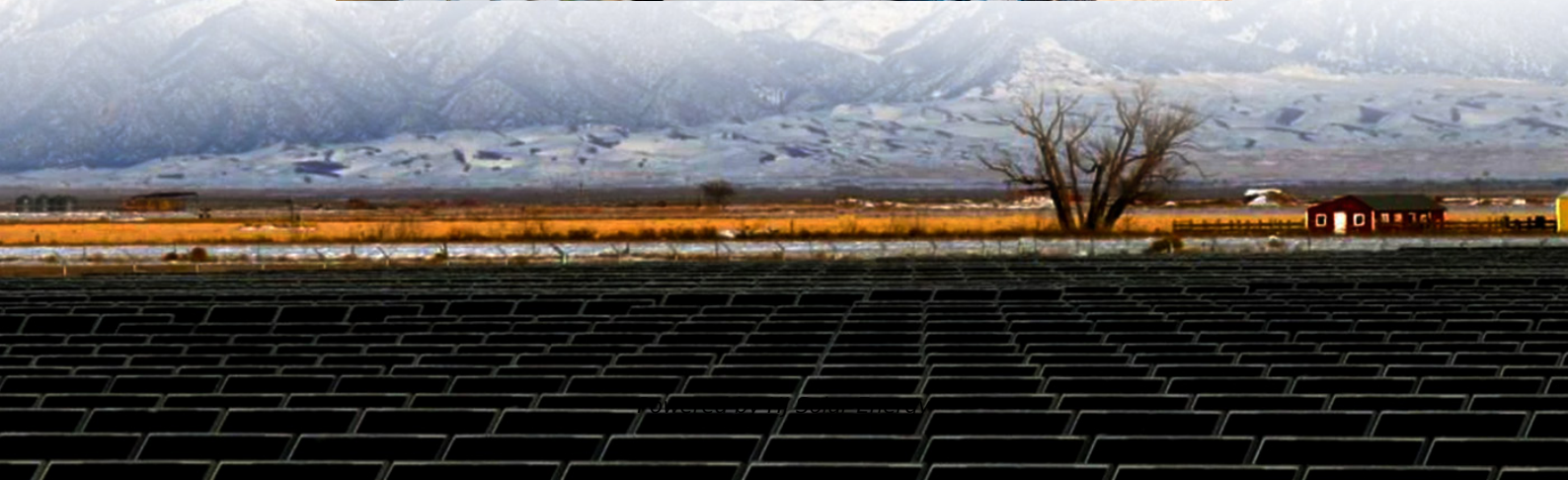


# **Successful bid price of MW scale storage system project in Greece 2026**

Greece has launched its third and final tender under a 1-GW program to support standalone battery energy storage systems (BESS), aiming to allocate 200 MW of capacity with available subsidies of EUR 200,000 (USD 217,920) per MWh. This move, approved by Greece's Regulatory Authority for Energy.

The average subsidy price in the third auction exercise came at €52589.16/MW/year. The lowest successful bid stood at €43927/MW/year, concerning a 25 MW/100 MWh project in the Western Macedonia region. The highest awarded subsidy came at €58773/MW/year and refers to a 7.9 MW/31.6 MWh project.

While 12 projects won awards in the first tranche of Greece's recent grid-scale energy storage auctions, what of the c.500 totalling nearly 27GW that didn't?

The Greek Regulatory Authority for Energy has confirmed that 411.8 MW of projects have been awarded in the country's first standalone battery energy storage system (BESS) tender, which has attracted huge interest among developers. Investment and operating aid will be granted to 12 projects put forward by seven proponents.

How many MW of new battery storage capacity does Greece have?

The Greek authorities have awarded 300 MW of new battery storage capacity in its second energy storage tender. The 11 winning projects range in size from 8.875 MW/17.75 MWh to 49.9 MW/100 MWh.

How many MW can you bid for a project?

Further restrictions complicated the bidding process, including a maximum capacity of 100MW per project and 300MW per region, and no participant allowed to win more than 25% of any auction. These restrictions meant that Eunice and Piritium both bid 50MW for projects licensed at 250MW/1000MWh and 150MW/450MWh respectively.
