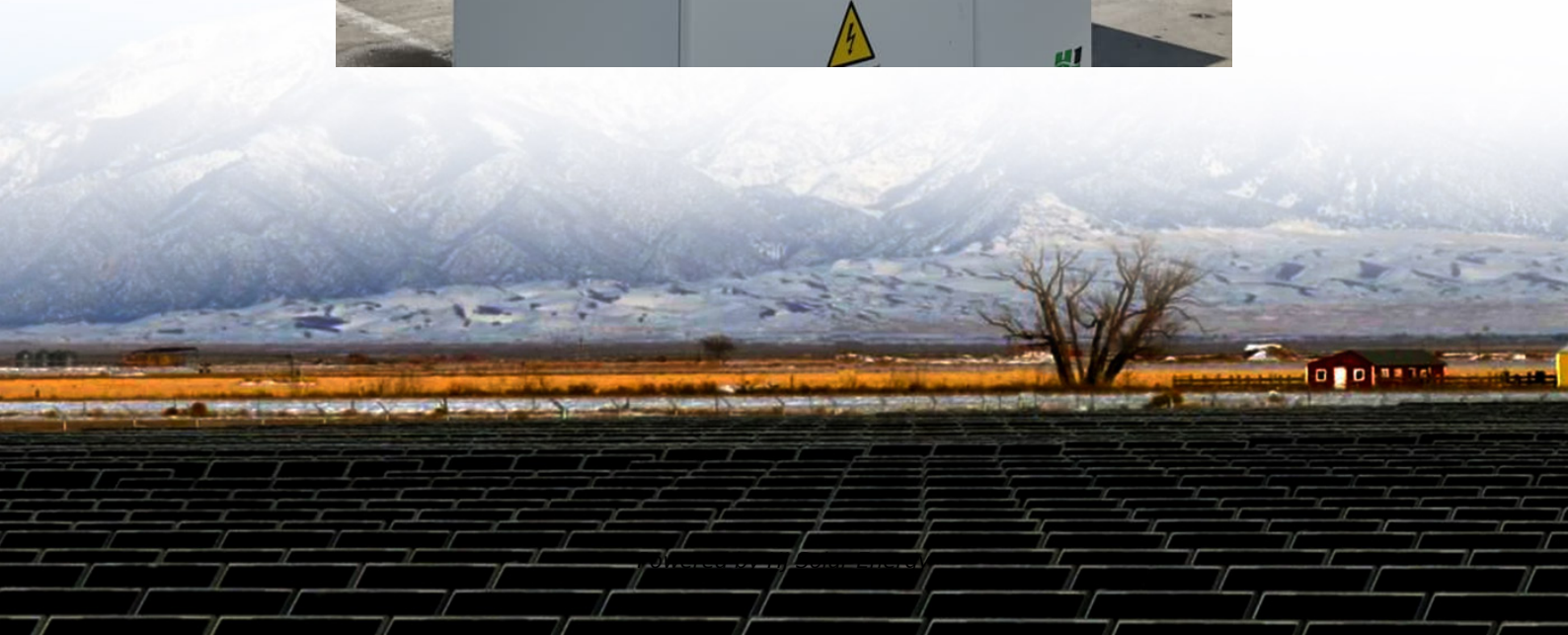

Not all states classify BESS as a renewable energy facility for purposes of a property tax exemption or exclusion. In those that do, the exemption or exclusion may require the BESS to co-locate next to a renewable energy facility. Typical exemptions or exclusions available for BESS vary by state.

The Inflation Reduction Act (IRA) was signed into law in August 2022, introducing significant enhancements to federal energy tax credits for various clean energy technologies. These technologies include solar power, battery storage, alternative energy vehicles and charging stations, cogeneration.

The taxation imposed on energy storage power stations varies significantly based on several factors including jurisdiction, the nature of energy storage technology deployed, production capacity, and whether the power station

Many states have either a solar or wind exemption, which provides that equipment used for electricity generation by either solar or wind be exempt from sales tax. Florida, for example, provides an exemption for solar energy systems, and New York provides a specific sales and use tax exemption for. Who can install energy-generation & storage property?

Tax-exempt and governmental entities, such as state and local governments, Tribes, religious organizations, and non-profits may install energy-generation and storage property to meet energy demands, reach clean energy transition goals, or save money on energy costs.

What regulatory guidance has the government released on energy storage?

Of particular importance to the energy storage industry, the government has released final regulatory guidance for the ITC (both Section 48 and 48E of the Code), prevailing wage and apprenticeship (PWA) requirements, and transferability and direct payment, as well as other guidance on the energy community and domestic content tax credit “adders.”.

Does Washington have a sales tax exemption for solar energy?

Washington also provides a sales tax exemption for solar energy system machinery and equipment under specific criteria. States generally treat electricity as tangible personal property for sales tax purposes and thus may provide for manufacturing exemptions.

What are the New IRA rules for energy storage?

Energy storage was one of the major beneficiaries of the IRA’s new rules on both the deployment and manufacturing sides. The IRA enacted the long-sought investment tax credit (ITC) under Section 48 and 48E of the Internal Revenue Code (the Code) for standalone energy storage facilities.

Is a stand-alone energy storage a qualified person?

Notably, no NAICS code describes stand-alone energy storage, and there is no published guidance on whether a stand-alone BESS could be a qualified person. Stand-alone BESS is subject to property tax. Texas offers an incentive program referred to as chapter 312 to attract new capital investment that has benefitted renewable development.



Are IRA tax benefits a viable option for energy storage facilities?

While the vitality of the IRA tax benefits in their current form is currently subject to uncertainty given the results of the 2024 federal general election, the existing market practice for financing energy storage facilities since the IRA's passage continues to evolve in reaction to the act's new requirements and opportunities.

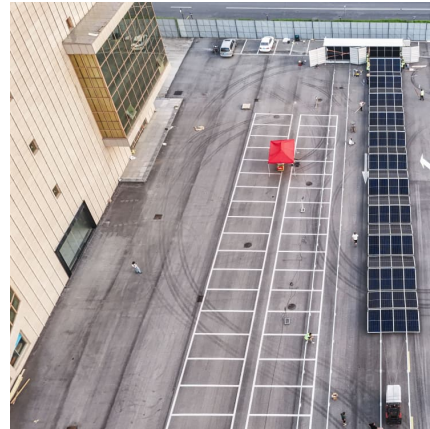

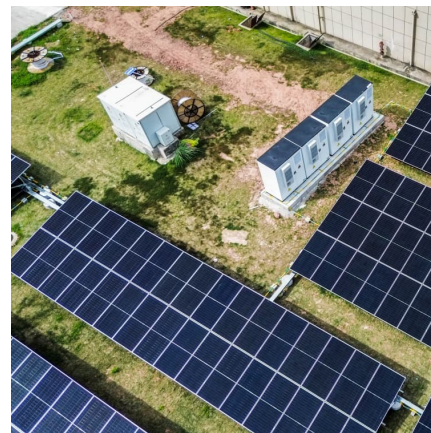

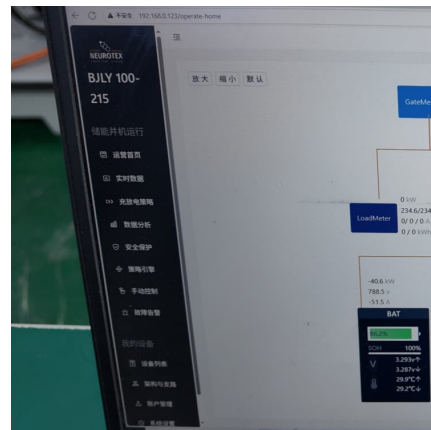
