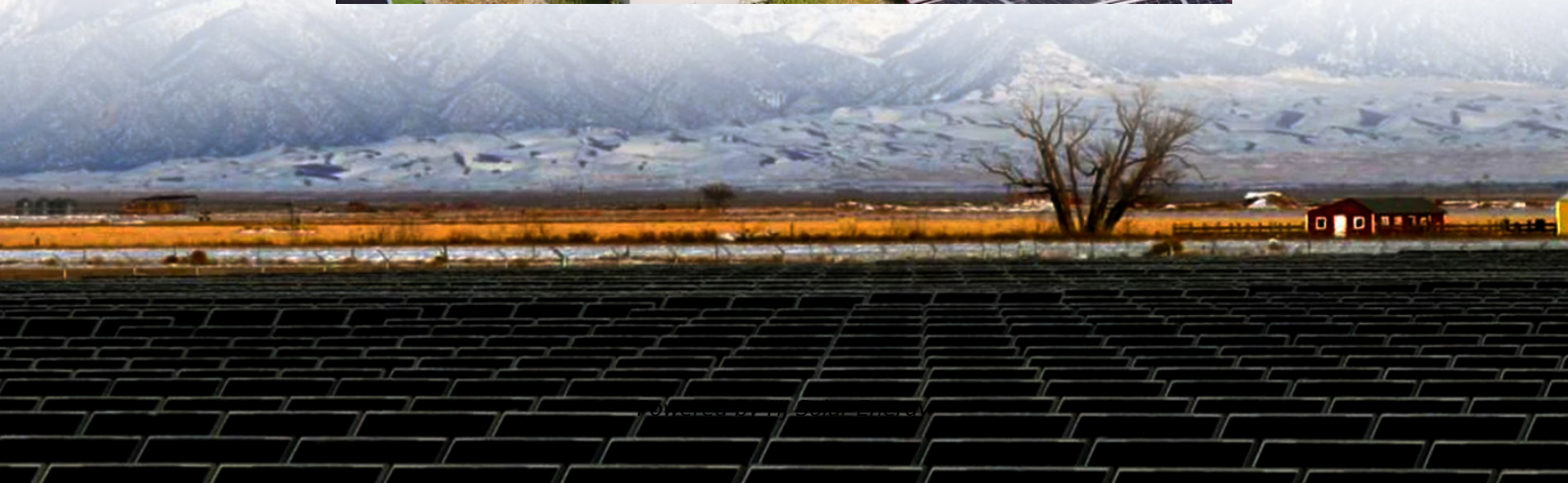


Total investment cost of enterprise ESS system project in Mauritius





Overview

SMEs in Mauritius operate under an ecosystem. The dynamism of this ecosystem interrelates with several factors and acts at different levels, including the Own Account Workers / Entrepreneur level.

What are operational and maintenance costs in Mauritian rupees?

equipment. A rough estimate is required, but if detailed cost estimates are available.

Should SMEs be established in Mauritius?

The Master Plan recommends that SMEs in Mauritius should be incorporated as a parastatal organisation, with a board constituted equally of public and private sectors' representatives and has a clear mandate to provide targeted and differentiated support to SMEs.

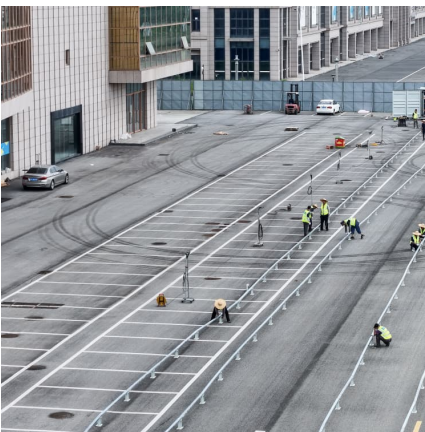


Public Sector investment Programme

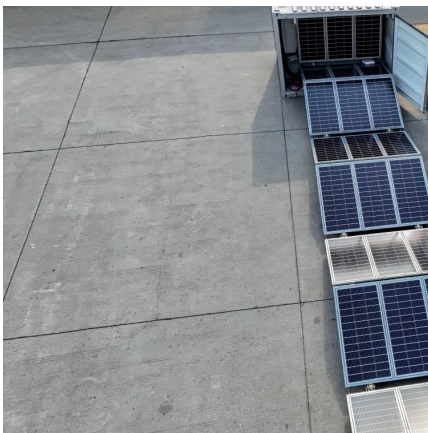
