Overview

How will the European Commission support large-scale energy storage in Spain?

The European Commission on Monday approved a new aid scheme for the deployment of large-scale electricity storage in Spain. Subsidies will be available for standalone energy storage sites, projects installed alongside renewable energy facilities, and storage planned as part of thermal power plants.

What funding opportunities are available to support Europe's Energy Future?

A wide range of EU funding opportunities are available to help support Europe's clean, secure and affordable energy future. The EU's Cohesion Fund aims to reduce economic and social disparity between EU countries and promote sustainable development.

Does Spain support energy storage?

Spain already backs energy storage with more than €600 million of NextGenEU funding which was allocated as part of Spain's, post-Covid Recovery, Transformation, and Resilience Plan. From pv magazine España.

Which EU countries will benefit from a low-income investment fund?

This fund will contribute to the investment needs of the 13 lower-income EU countries: Bulgaria, Croatia, Czechia, Estonia, Greece, Hungary, Latvia, Lithuania, Poland, Portugal, Romania, Slovenia and Slovakia.
