

Wind solar storage tender price in Luxembourg 2026





Overview

Luxembourg is putting up €52.4 million (US\$56.7 million) for the scheme. The bidding window is open until 4 th March, 2025, and all PV projects must be operational within two years of the window closing, while wind must be operational within three.

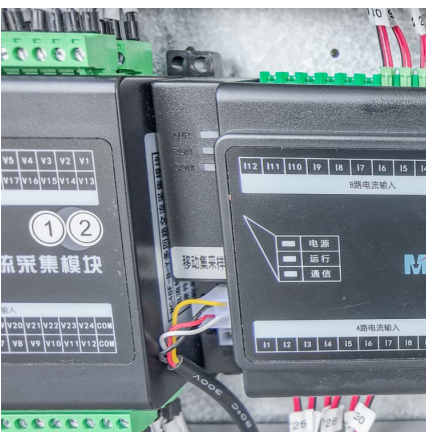
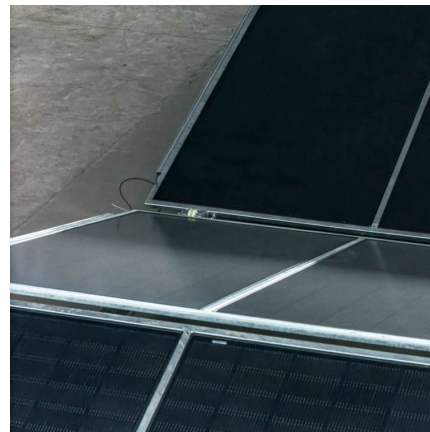

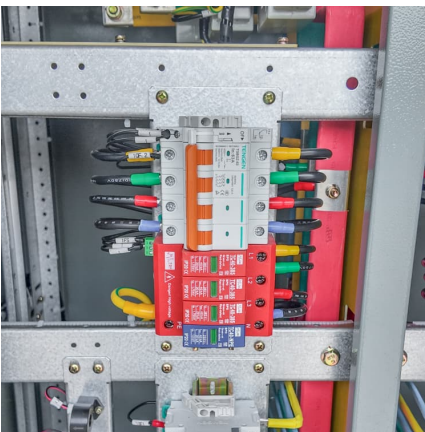
